
Follow these steps to get registered

1. Go to **LincolnFinancial.com/Register** and enter your email address, ZIP code, and phone number. Click **CONTINUE** and enter your name, date of birth, and the last 4 digits of your Social Security number. We'll text or call you with an authentication code to verify your identity and establish two-factor authentication (TFA). Create a username and password to log in.
2. During your next login, you'll have the option to select **Remember this device**. If you check this box, you won't be prompted for TFA on that device for 30 days.



IMPORTANT:

Keep your username and password in a safe place for easy reference on return visits to your online account.
